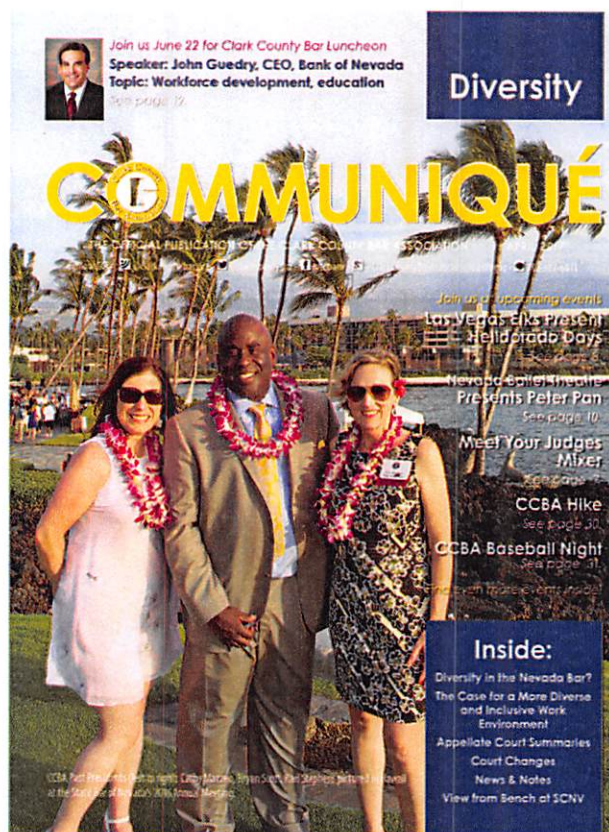
### The Purpose of the Clark County Bar Association is to:
